The Association shall purchase and install a cutoff valve and a water meter in each service. The Association shall have exclusive right to use such cutoff and water meter		
The Association shall have final authority in any question of location of any service line connection to its distribution system, shall determine the allocation of water to Members in the event of a water shortage, and may shut off water to a Member who allows a connection or extension to be made of the Member's service line for the purpose of supplying water to another user. In the event there is a shortage of water, the Association may pro-rate the water available among the various Members on such basis as is deemed equitable by the Board of Directors, and may also prescribe a schedule of hours covering the use of water for garden purpose, etc. by particular Members and require adherence thereto or prohibit the use of water for garden purposes, etc. provided that, if at any time the total water supply shall be insufficient to meet all of the needs of the Members, the Association must first satisfy all the needs of all Members for both domestic and livestock purposes before supplying water for garden purposes, etc (initial here)		
The Member agrees that no other present or future source of water will be connected to any water lines served by the Association's water lines and will disconnect from the present water supply prior to connecting to and switching to the Association's system and shall eliminate their present or future cross connections in the Member's system.		
The Member shall connect the service lines to the Association's distribution system and shall commence to use water from the system on the date the water is made available to the Member by the Association. Water charges to the Member shall commence on the date service is made available, regardless of whether the Member connects to the system.		
In the event the Member damages any asset of the Association, then that Member will be required to reimburse the Association for the cost to repair such damage. The cost to repair will include materials, labor, water loss, and any other factors deemed relevant by the Association (initial here)		
The failure of a Member to pay water charges duly imposed shall result in the automatic imposition of the following penalties: 1) Nonpayment by the due date will be subject to a late fee of 10% of the amount due; 2) Nonpayment by the due date will result in a \$25.00 fee being added to the amount due; 3) In the event it becomes necessary for the Association to shut off the water from a Member's property, a \$25.00 reconnect fee must be paid plus the entire balance of bill before service will be restored. No water is restored after office hours or weekends.
